1	(Whereupon, the following proceedings
2	were held in open court, commencing
3	at 4:13 p.m.)
4	THE COURT: All right. Attorney Montenagro, and,
5	Attorney Walker, if you want to just approach, I don't
6	want to have all the people yet. I just want to make
7	sure I know where I'm at. Okay?
8	MR. MONTENEGRO: Thank you, Judge.
9	THE COURT: At this point I apologize. I'm
10	running late.
11	MR. MONTENEGRO: No apology, Judge. Thank you so
12	much.
13	THE COURT: So I sent both of them down to do
14	testing.
15	MR. MONTENEGRO: Yes, sir.
16	THE COURT: And it looks like they were both
17	clean, correct?
18	MS. WALKER: Yes, Your Honor.
19	MR. MONTENEGRO: Yes, Judge.
20	THE COURT: So both of these go in the file and
21	are sealed. Can I take a moment to make sure that
22	MR. MONTENEGRO: Yeah, please.
23	THE COURT: Because there were several
24	kerfuffles. Can I use that word?

1	MR. MONTENEGRO: Yes.
2	MS. WALKER: Yes.
3	MR. MONTENEGRO: I haven't heard that in years.
4	We're dating ourselves. That's a good one.
5	THE COURT: There were several, apparently,
6	interactions between the parties that may or may not
7	have involved members of law enforcement.
8	MS. WALKER: There were, Judge.
9	MR. MONTENEGRO: Yes, sir.
10	THE COURT: And there was some confusion about
11	what court orders are in place or not in place. I
12	ordered a transcript of my proceedings.
13	MR. MONTENEGRO: Yes, sir.
14	THE COURT: Now, whatever happens outside of my
15	presence now has resulted in multiple pleadings,
16	correct?
17	MS. WALKER: Yes, Your Honor.
18	MR. MONTENEGRO: And what I did, Judge, is the
19	last that I filed in court is really the most
20	relevant, which is the motion to modify, and what I
21	did is I outlined what I believe the Court had done on
22	the May 18th, and I set it out in that motion as to
23	THE COURT: May 18th or May 30th?
24	MR. MONTENEGRO: I mean the May 30th. But, also,

1 [in the May 18th where you clarified what you had done
2	in the May 30th order when you revoked it.
3	THE COURT: Right. And I probably wasn't as
4	clear as I should have been. So I guess why I'm
5	bringing that up is that are all of these going to be
6	set for some kind of hearing today? You filed certain
7	motions.
8	MR. MONTENEGRO: I don't think we're going to
9	need to, Judge.
10	THE COURT: Katrina isn't represented. Am I
11	going to have formal written responses and set them
12	for hearings or
13	MR. MONTENEGRO: I think we're all going to be
14	able to resolve
15	THE COURT: We're all kind of just
16	MR. MONTENEGRO: Yeah.
17	THE COURT: And we're going to try to move past
18	that?
19	MR. MONTENEGRO: Yeah.
20	THE COURT: So at this point I know that Katrina
21	is here and she can hear me and she is with her
22	support people on this side, and Nick is present and
23	he's on the other side.
24	MR. MONTENEGRO: Doesn't he look better than what

1	he used to?
2	THE COURT: At this point, Attorney Walker, this
3	is the first time you've appeared.
4	MS. WALKER: It is.
5	THE COURT: I ordered that you be appointed as
6	guardian ad litem.
7	MR. MONTENEGRO: And thank you for that, Judge.
8	THE COURT: Well, thank her. And what is the
9	status today?
10	MS. WALKER: First, I want to apologize, Your
11	Honor. I was a little late because I had a Winnebago
12	County matter at 1:30 so
13	THE COURT: Well, I didn't get to you guys until
14	after 4:00.
15	MS. WALKER: That's all right.
16	THE COURT: So if anybody's late, it's me.
17	MS. WALKER: Well, it gave us time to talk about
18	the case. I think there were three issues that I've
19	outlined with the parties, as well as Mr. Montenegro,
20	today that are of concern to me. Number one was the
21	drug drop because there was allegations of drug use.
22	We've now taken care of that this afternoon. So at
23	least there's a baseline that both parties tested
24	negative.

1	THE COURT: Today.
2	MS. WALKER: Today.
3	The second issue, quite frankly, was I
4	think there was confusion at the last court date
5	regarding what Your Honor ordered.
6	THE COURT: Which is my fault.
7	MS. WALKER: I was not present. Mr. Montenegro
8	was not present. So I understand that Ms. Ainley had
9	an understanding of what Your Honor was ordering, and
10	I think Mr. Wisely and his counsel had a different
11	understanding of what you were ordering. I am not
12	you, and I was not here. So I don't know what Your
13	Honor was actually ordering. So that was my next
14	issue was what were you ordering and what was your
15	position?
16	THE COURT: I've ordered a transcript.
17	MS. WALKER: Okay.
18	THE COURT: I have the original. You can all get
19	copies for a fee, but I will tell you that here's my
20	recollection is that they were both self-represented.
21	They were both in front of me. She was objecting to
22	Nick having the parenting time pursuant to the other
23	order. He acknowledged to me that he had been
24	arrested for possession of a controlled substance.

1	MR. MONTENEGRO: Possession, yes, sir.
2	THE COURT: And so at that point I had some
3	indication that whatever, truthfully or not, he's
4	presumed innocent until proven guilty. And I get all
5	of that, but there's some corroboration to her
6	complaints. Judge Young and I'm going to refer to
7	myself in the third person and I get in trouble
8	when Judge Young tries to move the ball down the court
9	and advance it when I probably should just you
1.0	know, to use a similar analogy, I don't throw the
1.1	ball. I don't hit the ball. I don't catch the ball.
12	I should just call balls and strikes. Okay?
13	But I had these handwritten pro se motions
14	in front of me, and I was trying to advance it.
15	MR. MONTENEGRO: Yes, sir.
16	THE COURT: My recollection to your client was
17	that I was attempting to get him some parenting
18	time
19	MR. MONTENEGRO: Yeah.
20	THE COURT: but not overnight because that's
21	technically what Nicole was objecting to.
22	MR. MONTENEGRO: Agreed.
23	THE COURT: He and I got off on the wrong foot.
24	I used words from the bench I should not that he

1 [was arguing with me that he didn't want to have just
2	certain days from certain times to certain times, not
3	overnight.
4	And here's my quote. His demeanor and
5	response of arguing with me was that he says:
6	"MR. WISELY: I'll take that
7	then. I mean, I want my
8	weekend.
9	THE COURT: There's part of the
10	issue. Okay? You're in a
11	courtroom. I'm the one
12	deciding, and you're going to
13	piss me off?"
14	THE COURT: We were on the wrong foot. Okay?
1.5	And then he says, using my word back:
16	"MR. WISELY: I'm not trying to
17	piss you off. I'm saying
18	THE COURT: Then why are you
19	getting all angry at me about
20	it?
21	MR. WISELY: I'm not seeing my
22	kids. I haven't had my weekends
23	and stuff like that.
24	THE COURT: Here's the point,

1 [Nicholas. This is about ready
2	to go in the waste can and you
3	don't get to see him at all for
4	about a month.
5	MR. WISELY: Okay. I'm sorry.
6	THE COURT: My perception is I'm
7	giving you a break, and your
8	perception is she's Attila the
9	Hun and has no point, although
10	you're arrested for a cocaine
11	possession in Stephenson County.
12	MR. WISELY: Okay."
13	THE COURT: Brief pause.
14	"THE COURT: All right. I've
15	appointed Attorney Tamika
16	Walker. She's actually one of
17	the leading ones of the guardian
18	ad litems in the whole state."
19	MR. MONTENEGRO: That's right.
20	"THE COURT: Her address is
21	technically in Rockford, but she
22	usually meets over here. I've
23	appointed the percentage
24	breakdown on the retainer.

1	She's going to scan it."
2	THE COURT: Meaning the clerk.
3	"THE COURT: You can get copies
4	of it downstairs so you can
5	contact her. This reads 'This
6	matter coming on for
7	presentment. The GAL is
8	appointed. See separate
9	order."
10	THE COURT: Then the order is:
11	"It's ordered Nicholas shall
12	have parenting time as follows:
13	June 1st, 12:00 to 5:00; June
14	6th, 12:00 to 5:00; June 13th,
15	12:00 to 5:00; June 15th, 12:00
16	to 5:00; June 20th, 12:00 to
17	5:00. No overnights. Nicholas
18	may not consume any drugs unless
19	prescribed by a physician, and
20	the matter is set for further
21	status on June 27th at 2:30.
22	It's a short leash, Nicholas.
23	All right? Thank you very
. 24	much."

1 [THE COURT: I point to the bailiff, "Go out with
2	him." And at that point there's a disturbance, and
3	his demeanor is not what I expected. So then the
4	bailiff calls to him and I said:
5	"THE COURT: All right. Have
6	Nick have him come back all
7	the way back up here."
8	THE COURT: And then Ms. Ainley says starts to
9	say, "This is why," and I yell at both of them to
10	stop. "Give me all the orders back." And I meant the
11	12:00-to-5:00, 12:00-to-5:00, 12:00-to-5:00 orders.
12	"THE COURT: "Give me all the
13	orders back. Right here,
14	Mr. Wisely. What was that?"
15	MR. WISELY: I'm just upset
16	by
17	THE COURT: Give me the order.
18	Guardian ad litem is still
19	appointed. The other order is
20	just revoked."
21	THE COURT: I just revoked all of what I just
22	did.
23	MR. MONTENEGRO: Right.
24	"THE COURT: His motion for

1 [modification is heard and
2	denied. Contact the guardian ad
3	litem, and when the guardian ad
4	litem reports to me that you're
5	able to see the child, you can."
6	THE COURT: I meant he has no visitation until
7	the guardian ad litem says he can.
8	"THE COURT: You are dismissed.
9	Thank you very much. Make sure
10	he's gone all the way out."
11	THE COURT: I was not very clear. He was mad; I
12	was mad. I get in trouble when I get mad. What I
13	intended was that based upon his presentation that
14	day, based upon his demeanor, based upon what he was
15	saying to me, and based upon he had an outstanding
16	arrest that hasn't been resolved, I was going to order
17	that he not have any visitation.
18	MR. MONTENEGRO: Right.
19	THE COURT: I was going to I was going to give
20	him some time; and then he got upset and, frankly, I
21	got upset and I was going to revoke it. I didn't mean
22	that it goes all the way back to the other one. I
23	meant he gets no visitation until she says that he's
24	clean and he can.

1 [Now, that's where all the kerfuffle goes.
2	I should have had a specific order that says his
3	motion for modification is heard and denied and a big
4	court order: There is No Visitation.
5	MR. MONTENEGRO: Period.
6	THE COURT: Period.
7	MR. MONTENEGRO: Right.
8	THE COURT: I didn't do that.
9	MR. MONTENEGRO: Right.
10	THE COURT: So to the extent that that created
11	the confusion, I apologize to everybody to Katrina,
12	to Nicholas, to the police department, and to
13	everybody.
14	MR. MONTENEGRO: Okay.
15	THE COURT: But my intent, to answer your
16	question, Attorney Walker, is maybe I shouldn't have,
17	but my intent was he didn't get anything until you get
18	involved. Apparently, that's not what happened.
19	Now, to follow along, the Circuit Clerk
20	comes up about two days later and says, "I thought I
21	had ripped up all of the copies of the orders of
22	certain ones. Apparently, that did not happen." Now,
23	I'm not going to investigate it. I'm not sending up
24	the detectives. I don't know how he got I don't

know what order it is that he gave to the police 1 department to go and get the kids. If it's the very 2 old one that he thinks is still in place, my bad. 3 should have revoked it and said no. If it's the one 4 that I ripped up and he got a copy from her or 5 someplace else and took it, his bad. 6 Right. 7 MR. MONTENEGRO: THE COURT: Because that's clearly not what I 8 9 meant. And he didn't -- that MR. MONTENEGRO: Right. 10 wasn't the new order that you had ripped up. 11 THE COURT: So --12 MR. MONTENEGRO: It was based upon the old 13 judgment. 14 That I think I intended to say no. 15 THE COURT: That's my bad. Okay? 16 MR. MONTENEGRO: Okay. 17 THE COURT: So now I think we're here today. 18 have representation. I have the guardian ad litem, 19 and I have everybody present. I'm not going to try to 20 investigate anything else, but I think that's my 21 answer to your question is I intended nothing and then 22 he used the old order. My bad; I didn't write out 23

15	THE COURT: So that's all bad on me.
16	MR. MONTENEGRO: All right.
17	THE COURT: Okay?
18	MR. MONTENEGRO: So we didn't mistake the
19	interpretation of what it read.
20	THE COURT: Well, on the order. But that's not
21	what I said in court.
22	MR. MONTENEGRO: Right.
23	THE COURT: Or that's not what I meant in court.
24	And that's my bad.

1 [MR. MONTENEGRO: All right, Chief. We're good.
2	THE COURT: And I apologize to everybody that I
3	think I caused that kerfuffle. Now, again, in my
4	defense, it's another day like today.
5	MR. MONTENEGRO: Yeah.
6	THE COURT: You know, there's multiple things. I
7	don't have any lawyers to help me and I'm doing, doing
8	it.
9	MR. MONTENEGRO: Now you do.
10	THE COURT: But now I do. But that's my
11	recollection.
12	So having said all of that, I'm really not
13	sure that any of that at this point if other people
14	are going to make claim someplace and other people are
15	going to file suit someplace, then so be it and they
16	can all go do that.
17.	MR. MONTENEGRO: Right.
18	THE COURT: And then it shakes out
19	MR. MONTENEGRO: Right.
20	THE COURT: whatever it is.
21	But what I'm really concerned about today
22	is for the child that is having police people come and
23	take them from Grandpa. Okay?
24	MS. WALKER: Right.

1	THE COURT: Or whomever.
2	MS. WALKER: And that was my concern as well,
3	Your Honor.
4	THE COURT: So I interrupted you, Attorney
5	Walker.
6	MS. WALKER: That's okay.
7	THE COURT: You asked me a question. I went on
8	for seven minutes about what I meant, and I take full
9	responsibility. I don't think the orders were as
10	clear as they should be.
11	So now what was the third question?
12	MS. WALKER: Well, I think that what you've
13	described was my interpretation of what occurred, even
14	though I wasn't there because that just made sense to
15	me. But I understand why there would be a different
16	interpretation of it. After I got on the case and
17	spoke with Mr. Montenegro, I think we were able to
18	say, look, we need to see what the judge says first.
19	My third issue for today, my other
20	recommendation, other than the drug drop, asking what
21	your intention was, was also to see if Your Honor
22	would order the parties to go to PACT class because I
23	think that they need to understand how to co-parent.
24	I think both of these parties are very young. I do

Quite frankly, 20 Nicholas is acting like a 22 year old. Unfortunately, 21 he's a 22 year old with a child that he has to deal 22 And he can't do the things that normal 22 year 23 olds do such as spout off at the mouth on Facebook or 24

2	THE COURT: Or be disrespectful to
3	MS. WALKER: Or be disrespectful to the Court.
4	THE COURT: a judge in a courtroom.
5	MS. WALKER: That's a problem. Okay? My

8	deal with his client about that.
9	MS. WALKER: And my other concern was, to be
10	perfectly honest with Your Honor, if he's behaving like
11	this in court in front of Your Honor

10	MR. MONTENEGRO: Yeah, that's right.
11	THE COURT: Okay. If I have incidents at the
12	exchange, if I have any indication from the guardian ad
13	litem or anything else of there's illicit drug use
14	MR. MONTENEGRO: Yeah.
15	THE COURT: any of that stuff, it's going to
16	be suspended for a long time.
17	MR. MONTENEGRO: Right. But he'll also lose me
18	as counsel.
19	THE COURT: Well, I get that. Okay.
20	So then it goes back to Katrina, and at
21	this point I'm going to pick a really quick date.
22	MS. AINLEY: Okay.
23	THE COURT: And I apologize to you, Attorney
24	Walker, but this is moved up to the top of the front

1	burner.
2	MS. WALKER: I understand, Judge.
3	MR. MONTENEGRO: Oh, yeah.
4	THE COURT: Now, next week is July 4th so I'm
5	going to have to do something about that maybe because
6	that's not a court date for me.
7	MR. MONTENEGRO: Right.
8	THE COURT: So then two weeks is the 11th.
9	Technically, it's blocked, but today I put a bunch of
10	stuff in on that day.
11	MS. WALKER: I can't do the 11th. I have a DCFS
12	hearing all day.
13	MR. MONTENEGRO: Okay.
14	THE COURT: So then the next date is the 18th.
15	MS. WALKER: I can do the 18th in the morning.
16	THE COURT: In the morning.
17	MS. WALKER: I have a hearing in Ogle County in
18	the afternoon.
19	THE COURT: All right. So now
20	MR. MONTENEGRO: July 18th? I could do the
21	morning.
22	THE COURT: July 18th in the morning.
23	MR. MONTENEGRO: I mean, either Peggy or I will
24	be here.

1	THE COURT: Status on all of it. So then the
2	question is what, if any, parenting time and under what
3	conditions do I do between now, which is June 27th, and
4	July 18th?
5	MR. MONTENEGRO: Only as what Tamika recommends.
6	THE COURT: Well, and she's going to go talk to
7	Katrina first.
8	MR. MONTENEGRO: Yes.
9	THE COURT: And then I'm going to step off, and
10	then we're going to reconvene so that at this point I
11	have expressed what I thought happened.
12	MR. MONTENEGRO: Yeah.
13	THE COURT: And I have now apologized three
14	times. This will be four times. I apologize for the
15	confusion. And at this point based upon those
16	comments, meet with Katrina and make the
17	recommendation, and then I'll retake the bench. Okay?
18	MR. MONTENEGRO: Okay.
19	MS. WALKER: Okay.
20	MR. MONTENEGRO: Thank you, Judge.
21	THE COURT: Thank you very much.
22	(A 48-minute recess ensued.)
23	THE BAILIFF: Please remain seated. Court is
24	back in session.

1	THE COURT: All right. Attorney Walker, and,
2	Attorney Montenegro, if you would approach? And,
3	Katrina, you can still hear me, correct?
4	MS. AINLEY: Oh, yes.
5	THE COURT: All right. I want them to stay
6	there.
7	MS. WALKER: Okay. We have an order, Judge, that
8	the parties will both sign up for the PACT class within
9	five days. Does Your Honor have the PACT class
10	brochures?
11	THE COURT: I don't think I have it here. I
12	think they're downstairs.
13	MR. MONTENEGRO: Yeah, we can get them
14	downstairs.
15	MS. WALKER: Oh, okay.
16	THE COURT: But I think they're closed.
17	MR. MONTENEGRO: Oh, okay.
18	MS. WALKER: Okay.
19	MR. MONTENEGRO: I'll I can email him. We
20	have them at our office. Online, too.
21	MS. WALKER: I can mail you yours, probably the
22	best that I can do right now. We have them in my
23	office, too, but I've got to get back to the
24	MS. AINLEY: So they have them downstairs,

1	though, right?
2	THE COURT: Right.
3	MS. WALKER: Yes. They have them at the clerk's
4	office.
5	THE COURT: Right.
6	MS. AINLEY: I could come down tomorrow.
7	MS. WALKER: Okay. And there's various language
8	about the different pleadings, but I think the most
9	important orders are Mr. Wisely's going to exercise
10	parenting time. We have listed all of the specific
11	days and specific times
12	THE COURT: Okay.
13	MS. WALKER: that his parenting time will
14	occur.
15	THE COURT: No overnights.
16	MS. WALKER: No overnights. That Mr. Wisely and
17	either Ms. Ainley or her husband will exchange the
18	minor at the Shopko in Belvidere, that no other persons
19	may be present at exchanges.
20	THE COURT: Okay.
21	MS. WALKER: That Mr. Wisely and his mother are
22	permitted to attend the child's tee ball, but then the
23	parties, nor their families, will have contact with
24	each other or engage in harassing conduct. The parties

1	will have no communication with each other except for
2	the purposes of discussing the minor by text or
3	telephone. Neither party shall consume illicit drugs.
4	Neither party shall, nor shall they permit
5	their parties to, speak negatively about the other
6	party when the minor is present. And we've set the
7	matter for status on July 18th at 9:00 o'clock.
8	THE COURT: In between now and then you're going
9 .	to try to attempt to do visits or what?
10	MS. WALKER: What do you mean attempt to do
11	THE COURT: Who else are you going to meet with
12	before
13	MS. WALKER: Well, that was my next question.
14	Does Your Honor require me to have a court order to
15	meet with collaterals? Because if so, I have to have
16	that court order. Or can I just do my investigation?
17	I know there's a local rule that gets a little
18	confusing about what you, the judges are
19	THE COURT: On this one I want you to meet with
20	the collaterals.
21	MS. WALKER: Okay. Then I can do that.
22	MR. MONTENEGRO: Right. And I have an order to
23	that effect.
24	MS. WALKER: Okay.

1	MR. MONTENEGRO: I'd rather her have this order
2	in case someone tries to get in your way.
3	THE COURT: All right.
4	MR. MONTENEGRO: So let's let you have an order
5	on that.
6	MS. WALKER: Okay.
7	MR. MONTENEGRO: And I made it very broad for
8	you, too.
9	MS. WALKER: Thank you.
10	MR. MONTENEGRO: You're welcome.
11	THE COURT: I just want to ask Attorney Walker if
12	we could email your copies to you?
13	MS. WALKER: Yes.
14	THE COURT: So that Katrina can have the yellow
15	ones today and we're going to so if you would wait a
16	moment, Attorney Walker
17	MS. WALKER: Okay.
18	THE COURT: Katrina's going to get the yellow
19	ones.
20	MS. WALKER: Okay.
21	THE COURT: Originals we're going to scan, and
22	she's going to copy them for everybody right now.
23	MS. WALKER: Thank you, Judge.
24	THE COURT: And then at this point, just another

1	comment to both parents: My standard is what's in the
2	best interest of your child. They should both remember
3	that. Okay? Thank you very much. See everybody in
4	July.
5	MS. WALKER: Thank you, Judge.
6	MR. MONTENEGRO: Thank you, Judge.
7	(Which were all of the proceedings of
8	record heard in the above-entitled
9	matter in this session, concluding at
10	5:28 p.m.)
